# The plan is for Canfor to Partner with Takla on building the camp, Canfor will pay SDC to operate the camp and SDC will own the camp










- 1) Contract Camp suppliers to

  - II. Ship to site and build camp
  - III. Operate Camp
  - IV. Contract the camp operation/ catering for 3 years term; with the option for a Takla community member company to JV or take over the catering/camp operation at that time.

- d. Supply hauling








### **Proposed camp accommodation goals**

#### **Modern Style Camp**

Focused on worker accommodation and health the goal is for the new Lovell Cove camp to be an attractive environment for people to stay and work

- > High speed internet
- > Heath & Exercise facility's
- > Private or semi-private washrooms
- > 100 person camp





#### **New Camp Location**

- New camp will be 1/2 the size of the previous one
- Reuse fuel tank farm on old site
- Reuse previous septic and drainage containment if they meet current environmental standards
- > Will need to dig a new well
- There are no plans to use the rail line or log yard





#### WHY A NEW CAMP LOCATION?

- > Move The Camp will be owned and operated by the Takla Nation
- > Move from old camp site with historical problems
- > Locating the camp infrastructure closer to the lake will allow for the potential of hooking up community member housing to water sewer in the future
  - > Current camp location has to pump water over 2k from the lake
- > Will allow the camp buildings to be used for tourism and other uses
- > Will help attract and retain workers

Target operational date. May 19, 2020

We will try to build the camp with a smaller environmental footprint


- > Propane or LNG Gensets

Using that expanded network to provide internet services in the broader geographical area Buckley house to Takla Narrows possibly??






Realign approximately 12.5 km of mainline around adverse B-Hill grade

- > Sasuchan is managing the project on behalf of Canfor
- The road is being realigned to lessen the grade to allow for loaded logging trucks to go south on the Driftwood from north and west of Lovell cove
- > A small section of road will also be realigned to connect the Fall-River road to the new road
- Engineering / survey and right of way ribboning to happen in the summer-fall of 2019
- > Right of way clearing and grubbing winter of 2019/20 full construction 2020
- > Camp will be constructed using existing mainline







#### **T-Road Temporary Camp**

- $\triangleright$  Same location as old #5 Timber camp  $\approx$  23 km on the T road
- **▶**Temporary camp location for winter of 2019/20 maybe 2021?
- >SDC managing the site clearing, and re installation of the well and septic systems for Canfor
